

Terms and Conditions for the FIS – Engineering Bursary for April 2024 intake

The RM7,000 Foundation in Science and Engineering Bursary ("FEB") is applicable for April 2024 intake for Foundation in Science programme offered at Heriot-Watt University Malaysia ("HWUM").

1. Applicants must submit a complete and accurate application to HWUM and pay RM500 for Registration Fee together with the full 1st semester tuition fee of the programme applied.

- 2. The bursary is awarded in the form of a tuition fee waiver only. It does not cover any other charges of fees such as resitting of examination fee, extension of studies fee, etc.
- 3. The applicant is eligible for a RM2,000 discount when applying for the Foundation in Science programme leading toward an undergraduate Engineering degree programme in the subsequent academic year.
- 4. Only applicants who progresses to an Engineering Undergraduate Programme will be eligible to enjoy the remaining RM5,000 of FEB waiver.
- 5. The FEB could potentially be applied in conjunction with one of the following.
 - FEB and Visa Application Fee Waiver and Early Bird Waiver and HWUM High Achievers' Scholarship (HAS)
 - FEB and Visa Application Fee Waiver and Early Bird Waiver and Family Discount
 - FEB and Visa Application Fee Waiver and Early Bird Waiver and Alumni discount

Please note that the waiver will not be granted for applicants with WISE scholarship or industry-sponsored scholarships.

6. The FEB is neither transferable nor exchangeable for cash or other alternatives.



- 7. The FEB is only applicable for study at HWUM, and it is not transferable to other HWU campuses or locations.
- 8. The FEB is forfeited in the case of deferment or withdrawal of studies.
- 9. In case of application withdrawal and refund request, the FEB is not refundable. The following is an extract of the refund policy for reference:

Refund policy.

- a. The Registration Fee and Visa Application Fee are not refundable under any circumstances.
- b. Subject to sub paragraph (a), if a student provides notice more than 2 weeks before the commencement of the semester, 100% of the tuition fees paid may be refundable.
- c. Subject to sub paragraph (a), if a student provides notice within 2 weeks before the commencement of the semester, 50% of the tuition fees paid may be refundable.
- d. Subject to sub paragraph (a), if a student provides notice within 2 weeks after the commencement of the semester, 50% of the tuition fees paid may be refundable.
- e. No fees are refundable 2 weeks after the commencement of the semester.
- 10. Notwithstanding anything to the contrary, the FEB is granted at the sole discretion of HWUM. HWUM reserves the right to change the FEB structure or terminate the FEB at any time at its discretion.
- 11. HWUM reserves the right to make any amendment to the terms and conditions herein and will use its best efforts to inform the eligible students accordingly.
