

CODE OF PRACTICE FOR THE MANAGEMENT OF MULTI-LOCATION , MULTI-MODE PROGRAMMES

Summary

1. The University's **Code of Practice for the Management of Multi-Location, Multi-Mode Programmes** was published in November 2013.
2. The Multi Code comprises four Parts:
 - 1) The Student Experience
 - 2) Management and Assurance of Quality and Standards
 - 3) Management of Programmes and Partnerships
 - 4) Quality Enhancement
3. Each Part comprises an overall **Expectation** and series of **Principles** with accompanying **Explanations**.
4. The Multi Code aims to underpin the key HWU principle of *identical academic standards; diversity of learning experiences*

Purpose

The University has published its 4-Part **Code of Practice for the Management of Multi-Location, Multi-Mode Programmes**. The key purposes are:

To assure the academic standards of multi-location, multi-mode programmes

To assure and enhance the quality of the learning experience of students on programmes outwith the UK campuses

To provide a framework which:

- supports current and future international activity
- is as rigorous, secure and open to scrutiny as that in place for UK campus programmes
- safeguards academic standards
- helps to manage potential risks, challenges and complexities
- enables the University to meet all Expectations and relevant Indicators of the QAA UK Quality Code

Scope

The Multi Code applies to programmes offered at a UK campus which are also delivered, supported and/or assessed:

- at an Overseas Campus
- at an Associate Campus
- through an arrangement with an academic partner
- via independent distance learning

Key Areas

The key areas within the four Parts of the Multi Code:

- Representation and Feedback
- Award
- Employment

Part 2: Management and Assurance of Quality and Standards

- Selection and Negotiation
- External Approval
- Approval and Contract Signing
- Start Up
- Monitoring and Review
- Development
- Termination

Part 4: Quality Enhancement

- Development and Approval of Strategy
- Implementation
- Evaluation
- Dissemination
